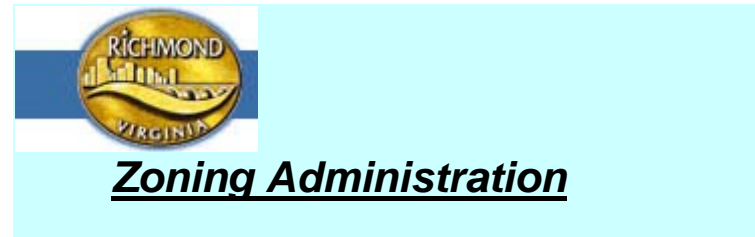

## **Zoning Administration duties include:**

### **Permit Review & Approvals -**

- Review of all *building permit (BP)* and sign applications to ensure code compliance with the City's Zoning Ordinance.
- Review of *Certificate of Occupancy (CO)* applications and inspects development for conformance with regulations for issuance.
- Process Administrative Variance requests and approvals.
- Conducts intra- and inter-agency review of projects for *Commission of Architectural Review (CAR)*, *City Planning Commission (CPC)*, and *Urban Design Committee (UDC)* approval.
- Review of electrical permits for exterior parking lot lighting.
- Review of trade and tank permits for properties in historical areas involving exterior elements that are visible from the public right-of-way.
- Review of plumbing permits for adding plumbing fixtures in accessory structures or plumbing fixtures that might create a second kitchen in a single-family dwelling.
- Review of applications involving exterior work, including paint color, located in a *City Old & Historic District*.
- Review of *Work-in-Street (WISP)* and Land Disturbance permit applications.

### **Small Business Coordination -**

Assists small businesses in obtaining necessary approval(s) to begin operation and facilitates the obtaining of business license approval, including review and issuance of *Home Occupation* approvals. Assists the *Office of Minority Business Development (OMBD)* by providing staff support to small and minority business owners in developing business and marketing plans, preparing finance strategies and negotiating the bid process.

### **Zoning Advice and Analysis -**

Provides over-the-counter assistance to walk-in customers, and answers telephone inquiries from the public. Provides inter-agency support and analysis regarding zoning information and other development issues, including:

- Subdivision of land;
- *Special and Conditional Use Permits*;
- *Plan of Developments (POD's)*;
- Re-zoning and other land use approvals; and,
- Zoning text amendments, updates and studies.

### **Zoning Confirmation Requests -**

Reviews *Certificate of Zoning Compliance (CZC)* and *Zoning Confirmation Letter* requests to ensure development has been completed and is maintained in conformance with requirements.

### **Board of Zoning Appeals -**

Provides staff support and coordinates and prepares necessary documentation for monthly *Board of Zoning Appeals (BZA)* agendas for *Variances*, *Special Exceptions* and appeals of decisions of the Zoning Administrator.

### **Code Enforcement -**

Investigates complaints from the public, City Administration and City council on zoning violations and takes appropriate action to seek voluntary compliance of zoning regulations or initiates court proceedings to force compliance.

### **State and City Agency Reviews -**

Provides assistance, review and approval for State of Virginia and other City agencies regarding development and licensing issues, including:

- *Department of Motor Vehicle (DMV)* license review and approvals;
- *Virginia Department of Transportation (VDOT)* permit review and approvals;
- *Virginia Department of Environmental Quality (DEQ)* project reviews and approvals;
- *Virginia Department of Social Services (DSS)* license review and approvals
- *Virginia Department of Mental health, Mental Retardation and Substance Abuse Services (DMHMRSAS)* license review and approvals
- *Alcohol Beverage Control (ABC)* license review and approvals;
- *Department of Public Works (DPW)* review and approval for *Work-in-Street Permit (WISP)*, land disturbance, encroachment permit, street widening and other right-of-way enhancements and projects; and,
- *Department of Real Estate Services (DRES)* review of tax sale properties.

### **Zoning Ordinance & Zoning Web-Page Maintenance -**
